**RESOLUTION FOR THE ADOPTION OF THE PHILIPPINE AGRICULTURAL  
ENGINEERING STANDARDS (PAES) AS THE TECHNICAL STANDARDS OF  
AGRICULTURAL ENGINEERING**

**WHEREAS**, Section 40 of R.A. 8559 provides that the Board of Agricultural Engineering in collaboration and consultation with the Philippine Society of Agricultural Engineers and concerned agencies, government and private shall immediately prepare, develop and promulgate a Code of Technical Standards of Agricultural Engineering which shall contain standard design and test procedure, material and process specification.


**WHEREAS**, the Philippine Society of Agricultural Engineers (PSAE), duly accredited by the Professional Regulation Commission (PRC); the Department of Agriculture and the University of Philippines Los Baños through the Agricultural Machinery Testing and Evaluation Center (AMTEC) jointly prepared the Codes and Standards of Agricultural Engineering also known as Philippine Agricultural Engineering Standards for agricultural production, postharvest facilities, materials, and agricultural structures.

**WHEREAS**, these Philippine Agricultural Engineering Standards (PAES) have been presented during the 51<sup>st</sup> PSAE Annual Convention on April 23-27 at Cebu Plaza Hotel, Cebu City and in the Public Hearing held on August 27, 2001 at NAFC, Department of Agriculture, Diliman, Quezon City.




